A RESOLUTION CANVASSING RETURNS AND DECLARING RESULTS OF THE RUNOFF ELECTION FOR MAYOR; HELD IN THE CITY OF WHITE SETTLEMENT, TEXAS ON DECEMBER 8, 2020.

WHEREAS, on December 8, 2020, a Runoff Election was held in the City of White Settlement for Mayor; and

WHEREAS, after canvassing the returns of said election pursuant to the applicable provisions of the Texas Election Code, the Canvassing Board certifies the following are true and correct results, to-wit:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHITE SETTLEMENT, TEXAS:

Section 1. Publication and Posting. That said election was duly called; that notice of said election was given in accordance with the law; and that the canvass of the votes cast in said election and returns thereof were made in accordance with the law.

Section 2. Majority of Votes. Pursuant to the City of White Settlement Charter and applicable provisions of the Texas Election Code:

Mayor: Ronald A. White, having received a majority of votes cast, is hereby certified to be elected to the position of Mayor and shall commence his term of office upon the passing of this resolution, submitting the statement of elected officer, and taking the oath of office as required by law.

Section 4. Posting of Canvass. The City Secretary of the City of White Settlement, having posted written notice of the date, place and subject of this meeting on the bulletin board located at City Hall, a place convenient and readily accessible to the general public, and said notice having been so posted and remaining posted continuously for at least 72 hours preceding the scheduled time of said

meeting.

Section 5. Attachment: A copy of the Early Voting Returns and the Election Day Returns shall be attached to the minutes of this meeting and shall be made a part thereof for all intents and purposes.
